

Hello!

Below is a brief overview of cost as well as insurance and our practice flows. If you have any questions, please let us know!

Your first visit with us will be a consultation with one of our doctors for \$275. After this appointment, we will schedule you to come back for comprehensive blood work where a variety of labs are drawn as well as a stool test and possibly hormone saliva as well. We also have labs that can test for mold, GI imbalances, heavy metals, and stealth infections - these labs all depend on what you and the doctor discuss.

When you come back in a month, as that is the turnaround time on the labs, you will come in for a 90-120 min appointment with either Dr. Jamine, Dr. Sasha, Dr. Hashmi, or Dr. Pavilonis.

In the first follow-up appointment, your doctor comes up with a plan of care unique to you. In that same week or the following week, you will see either our nutritionist Sarah or Benji to go over diet, lifestyle changes, and extra support.

The cost of the first follow-up visit which includes the nutritionist is \$975 for Dr. Jamine and Dr. Sasha. The initial follow-up with Dr Pavilonis or Dr. Hashmi is \$1500.

Subsequent visit pricing is based on testing and frequency and can range anywhere from \$125-\$550.

Our membership programs are either 3 months or 6 months and save you over 20% on each visit. Our packages with our NDs start at \$1260, and with Dr. Pavilonis' or Dr. Hashmi starting at \$2100. Outside of saving over 20% on visits, you also receive a discount on supplements.

We accept HSA and FSA, but we do not accept insurance for the visits. You may try to submit your receipts for reimbursement but we can't guarantee anything, although we have seen upwards of 60% back.

We do run blood labs through Northwestern with your insurance, most people pay between \$75-\$400 for those. We cannot give an exact quote for out-of-pocket expenses as everyone's insurance is different, we can only give a ballpark range. If anything is above \$400, we ask you to send it over to us so we can forward over to Northwestern to check for accuracy. Anything not covered by insurance is your responsibility.

You are more than welcome to call your insurance provider to see if Northwestern is within your coverage. We're also able to do payment plans as needed for larger purchases.
